



PRAXIS OF PARTICIPATION - A RETROSPECTION

Participatory approaches democratised research in development in an irreversible way. This journey was influenced deeply by veterans of participatory development, whose challenge to conventional wisdom about knowledge sowed the seeds for development research's biggest yet disruption. Half of the nearly 50 years of



the PRA (Participatory Rural Appraisal) journey is intrinsically linked with Praxis's own.

Almost 25 years ago, on August 14, 1997, Praxis was registered as an independent resource centre for participation. Since then, we have evolved to become a knowledge organisation with a repertoire of skills and knowledge gained from and with marginalised communities across India and the world.

Rural research of the 1970s was showing up the ineffectiveness of top-down and exclusionary methodologies of anthropologists and economists. Emerging out of this discontent, the late 70s saw the value of indigenous knowledge in challenging the knowledge superiority of development theorists. Over the next two decades, the exploration with rapid rural appraisals, predominantly in agricultural communities, showed a quick and cost-effective alternative to the long survey methods and the quick rural tourism methods. This approach prioritised learning directly from local inhabitants. The 1990s was also the decade that saw the birth of Praxis as the PRA division of ActionAid, and its subsequent registration as an independent entity in 1997. Globally, this period coincided with the transition from RRA to PRA, with scale-up and institutionalisation of PRA through newer networks, trainings and innovations.

For Praxis, this period also marked the launch of our flagship event The Workshop – an annual international commune on participatory development, which today boasts of an alumni strength of more than 1800 participants from close to 50 countries.

In the 25 years of our existence, as part of the global journey, we engaged with concepts of power, downward accountability, participatory monitoring and evaluations, participatory statistics, community-led processes of influencing development decisions within movements, within the sector and within larger political realities, creating networks committed to social equity and human rights in many spheres including business responsibility. The last few years have been a great opportunity to reflect and engage with the shift from the 'paradigm of controllable' to the 'paradigm of complexity and re-sharpen our tools of engagement in the pandemic and post-pandemic world.

This year's annual report looks back not just at the year that passed us, but also at the 25 years of the Praxis journey that has brought us to this momentous period in development discourse where we confront a world of post-truth, of unbridgeable distances that the internet claims to be burning and of an ever-increasing unpredictability. We look at the contributions Praxis has made in this journey.

As we move towards the next 25 years, we express our gratitude towards all those who have been part of this journey - Praxians, our training alumni, project partners, and funding partners, as well as like-minded friends and professionals, who have been committed to making development and democracy truly participatory. We dedicate this milestone of ours to those marginalised communities across India as well as other parts of the world and all our cotravelers who made this journey possible.




Keeping with one of the core principles of the United Nations Convention on the Rights of the Child, Praxis over the past 25 years, has been committed to the rights of children by enabling them to participate in decision-making processes and ensure that their voices are heard. We have consistently innovated in ways of engaging with children - from creating spaces for their involvement in policy-making through ground-level panels on education and child labour, facilitating child-led manifestoes to agenda-setting, using digital inform political videos participatory videos to speak to a range of stakeholders about their aspirations and needs. We have contributed to knowledge-building around child-centred town planning in different states. The snapshot below reflects the spirit of our work since 1997.





The pandemic exposed vulnerabilities faced by children, putting them at higher risk of abuse, violence, poverty, and lack of access to quality education and healthcare. This past year, Praxis engaged with children to strengthen their voices to address issues that impact their lives deeply.



One of the projects aimed to mobilise communities and build digital narratives across three themes - air quality, girl capital, and adolescent sexual reproductive health services. As part of this project, adolescents were trained on identifying issues related to the above themes, making impactful videos to voice their concerns, and amplifying their voices using various media platforms and campaigns. Praxis trained 300 adolescents across four states: Jharkhand, Maharashtra, Rajasthan, and Uttar Pradesh, to map issues, find solutions and create messages over a three-year period. This project saw the launch of three campaigns -HerAkshar focused on sending girls to school to safeguard their future; Hawa Ke Rakshak focused on Air Quality, for more green spaces in their area to protect the community from industrial and vehicular emissions and positive actions to address pollution; Ankahee Baatein focused on groups sharing misconceptions and challenges surrounding sexual reproductive health.

Praxis trained organisations in Bihar to strengthen the capacity of Child Protection Committees (CPCs) using participatory tools to understand in-depth the challenges faced by children and plan strategies to implement activities at the village and ward levels. The project aimed to collate periodic data on dashboards from 40villages of one to three wards in Muzaffarpur and Vaishali districts, and to undertake periodic interactions with Child Protection Committees. The next step was to use the emerging trends from the data to plan engagements with panchayat, block, district, and state-level government functionaries.





With the aim to build a strong civic arm at the community level for improving access, creating demands, and ensuring effective monitoring of child protection needs and services, the new phase of strengthening community-based mechanism for Child Protection in Jharkhand, was commenced in April 2021. This new phase was marked with the addition of 20 villages across two districts of Jharkhand, Khunti, and Dhanbad, where Praxis facilitated

a series of workshops for existing as well as newly elected community leaders on the issue of child protection, and also formulated a village-level micro plan for strengthening civic arms in respective villages. An attempt was also made to build a state-wide network of civil societies working in the domain of child protection to scale up the model of community leadership building.



Praxis, with support from partners of an international organisation, conducted a study on children living in the slums of Bhopal, Madhya Pradesh. The study aimed at assessing the impacts of Covid-19 on child protection and documenting the types and magnitude of violence faced by them to generate leads for programmatic and policy advocacy for ending all forms of violence against children.

As part of a healthcare and education development programme in Jaipur, Praxis provided technical training to community-based fellows and volunteers. This included the creation of a module on child rights and a session on understanding inequality in gender relations. The fellows and volunteers were also trained on participatory methods, community engagement, and the action research process and were provided with periodic handholding support through regular interactions and follow-ups.

OUR WORK WITH WOMEN & SEXUAL MINORITIES

The fifth Sustainable Development Goal calls for gender equality and women's empowerment, principles intrinsic to sustained human and economic development. However, the poor status of women, girls, and other gender minorities is reflected in the rates of crime against women as well as in the widespread gender inequity in access to rights and opportunities. Praxis has, over the years, found ways of integrating a gender lens in all its work in addition to engagements that have looked at the empowerment of minorities. This developing and sexual included participatory tools which could be used by women in villages to analyse the causes of maternal death, research to inform and evaluate programmes on early marriage, female foeticide, trafficking for sexual exploitation, gender-based violence, and more. We also developed tools to evaluate the strength of collectivisation through community mobilisation monitoring selfassessment tools for use by community-based organisations of persons vulnerable to HIV/AIDS such as transgenders.


OUR WORK WITH WOMEN & SEXUAL MINORITIES

In the last year, our work aimed at addressing social inequities using a gender lens, strengthening the participation of women and other gender minorities in policy development.

Praxis conducted an exploratory study to get a comprehensive understanding of parental beliefs on the influence of employment before marriage on daughters' future marital prospects as well as the scope of employment after marriage that determine Female Labour Force Participation rates and patterns. The study aimed at unpacking notions of "good" marriage match and related factors; the perceived impact of education and employment; extent of perceptions in education; investment and on the soon-to-be-married. As part of the employment for engagement, 60 in-depth interviews and 8 focus group discussions were conducted with a wide range of parents and parents-in-law across caste, class, religion, and socio-cultural backgrounds.


Praxis carried out a participatory assessment of rural development projects in Bihar and Jharkhand centred around women's institutions' livelihoods and building sustainable community institutions with an objective to map key achievements and identify challenges and practices that need to be scaled up.

The victims of forced labour are often communities that are vulnerable such as children, women, gender minorities, the disabled, those in debt and other minorities. According to an ILO estimate, around 24.9 million people around the world are subjected to forced labour. This includes those who are exploited financially, physically, and sexually as well as by the private sector and individuals in positions of power. In the last decade, Praxis undertook several studies to understand the context of forced labour and trafficking within the country. This included evaluations of frontline organisations working with communities vulnerable to trafficking, extensive surveys to understand the prevalence of child labour, forced labour and trafficking, engagement with consortiums that focus on responsible business practices to prevent labour violations in the supply chain and strengthening the capacity of organisations working to prevent child labour.

In continuation with work carried out in the past few years, in the last year too, Praxis kept up the momentum in supporting initiatives that work with communities vulnerable to forced labour and survivors of labour rights.

Praxis was a facilitating partner in a study that aimed to capture the confidence of bonded labour survivors in the public justice system. It identified how survivors approached the existing justice systems and sustained their freedom. It aimed to provide insights into the experiences of care and protection from the justice systems and assess how confident the survivors were in receiving the rehabilitation measures and entitlements stipulated by the state. The study also captured how the survivors approached duty bearers, shedding light on whether survivors were able to engage with different stakeholders and build confidence among their communities to seek support. As a facilitating partner, Praxis supported the development of qualitative and quantitative research tools, reviewed the tools and trained the research team for collecting data from 319 survivors of bonded labour.





Praxis developed the Pathways digital case and data management service for frontline organisations working with communities vulnerable to bonded labour and trafficking to ensure that the communities at risk receive integrated care. It is an innovative case management software that makes it easier for organizations to maintain case records, streamline support provided to vulnerable persons, analyse their own data, and use it to engage with stakeholders to improve support from the state on various entitlements. Close to 30 organisations located across Bihar, Uttar Pradesh, Tamil Nadu, West Bengal, and Rajasthan currently use the service. Throughout the year, Praxis supported the organisations' staff to upload case data and use the service efficiently. The system currently has 191 active users, including mobile application users, and is managing over 3407 cases.

To enable communities to assess their capacity in addressing issues of forced labour, Praxis developed a toolkit, "the Community Maturity Tool". The framework of the tool comprised of five stages; conscious building, research, collation, self-assessment, and reflection which helped the communities score their awareness and identify vulnerabilities within the community and seek ways to address them. An instructional guide on how to implement each stage of the tool was also developed. The tools were presented to 14 NGO partners across the districts of Dindigul and Erode in Tamil Nadu. Praxis as technical support facilitated and trained the organizations, along with extending support in developing an Action Plan based on the tool findings.



Praxis was entrusted with upgrading the 'Empowerplus' web as well as a mobile application for facilitating reintegration and support to survivors of trafficking. The trilingual application, in Bangla, English, and Hindi languages was developed in 2020 to provide details of various resource organisations working in the domain of human trafficking in West Bengal and Jharkhand. The new addition to the application included online workshops and trainings, manuals of undertaking issues related to trafficking, and various others.

Despite the provision of equal fundamental rights to all citizens of the country, there are some who are discriminated against because of their social identity. They are subjected to mistreatment resulting in the loss of basic rights and dignity. As part of Praxis's commitment to social justice and equity, we have looked at the structural barriers that perpetuate historical injustices to continue unabated. By acknowledging participation is political Praxis aims to create spaces for the participation and inclusion of Dalits, Adivasis, Nomadic and Denotified Tribes, and Religious Minorities in all its work. The range of engagements included national infrastructure equity audits that examined the experience of Dalits, Muslims, and tribals accessing infrastructure, to strengthen community-led organisations and collectives. Praxis has been part of several consortiums such as the Social Equity Watch, Dalit Watch, and the National Alliance Group for Nomadic and Denotified Tribes which have advocated for their rights. Praxis has also placed these communities at the centre of any project or initiative to ensure an equitable lens to research.



The Collect Risk Communication & Community Engagement (CRCCE) is a community-led initiative covering 560 hamlets in 70 districts across 11 states and focused on Dalit, Adivasi, De-notified and Nomadic Tribes, and minority communities. The programme particularly focused on building a community-level resource base for easy access to information and instituting a system of data flow, which can be used to create an evidence-based system of communication with local administration. In these targeted hamlets of marginalised groups, access to digital tools is minimal and even when available, not everyone is able to access these tools owing to varied reasons ranging from ownership to access control.





In November 2021, RCCE (Risk Communities and Community Engagement) Collect initiative began a six-month programme focused on building community-level awareness on Covid Appropriate Behaviour (CAB) and ensuring higher vaccination through mobilisation among vulnerable groups. The programme selected hamlet-level and district-level fellows in each location from these groups. The key objectives of the six-month programme were as follows:

- 1) Fellows understand and practice CAB, are facilitated to make informed decisions about vaccinations and are provided access
- 2) Enhance capacity/understanding of CAB of volunteers to help them take the message to communities
- 3) Link the community with the local health services and administration for early COVID testing, treatment and vaccination with the view to the improvement of vaccination systems overall for the left-out dropped-out community.

Praxis engaged in strengthening individuals and budding organisations associated with socially relevant causes towards empowering them as "new age leaders" who can later take charge of the local development agendas, in four districts of Bihar. In the second phase of the engagement, four new fellows with a passion to work towards bringing changes in the lives of most vulnerable communities such as scheduled caste, sex workers, adolescent girls and sanitation workers; in the domain of access to livelihoods, rights for dignity, education and health, were identified.

Urban Delhi Shelter Improvement Board (DUSIB) operates community living facilities for the urban population homeless in the city. DUSIB appointed Praxis to monitor the condition of 16 such shelters in Delhi. The engagement includes periodic visits. interaction with and people living in the shelters to understand any challenges



they may be facing, and monitoring the condition of assets to recommend any purchases or repairs to the board. Based on interaction, women and children have expressed improvements in their living conditions in several shelters.

Praxis served as the anchor of the India hub of the Heritage for Engagement Network, which is a global network that aims at using humanitarian heritage to build sustainable peace. As part of this, Praxis anchored a research study bringing together four case studies from across India and neighbouring countries on how heritage can be used to build peace, especially among communities on the margins. The ENGAGE network India hub partners, which included government-recognised institutes working on architecture and planning, developed four case studies. These highlighted different dimensions such as distorted histories through the lens of the Chhara tribe; craft as process-centric heritage, commercialisation of cultural heritage through Kalbeliyas; and role of cultural institutions in urban resilience.

OUR WORK WITH COMMUNITIES EXCLUDED BY DISASTERS

Natural disasters accentuate social inequity by exposing deeprooted divisions in society. When the tsunami struck, Praxis was at the forefront of organisations coming together to critically explore the inequity in providing relief. Similarly, in Bihar, the repeated onslaught of the Kosi floods left some people more vulnerable than others. The vagaries of climate change and its effect on ecologically fragile Sundarbans push vulnerable groups to migrate in search of livelihood. Such communities join a large floating population of human capital, vulnerable because of their identity as well as the blow of natural disasters. From developing an application to track disaster-preparedness to carrying out equity audits in relief exercises, from carrying out a needs assessment of displaced persons to anchoring relief efforts, Praxis has engaged with vulnerable groups.

OUR WORK WITH COMMUNITIES EXCLUDED BY DISASTERS

Praxis supported the provision of relief in the ecologically fragile Sundarbans region of West Bengal to communities affected by the Yaas cyclone. As part of this initiative, communities were provided immediate support in the form of food, drinking water, health and hygiene kits, educational material for children, livelihood support, and awareness about the risks of trafficking under vulnerable conditions.

Praxis with support from 7 partner organisations working in Sundarbans of West Bengal, initiated relief work for the communities affected by the Amphan cyclone in 2020. In this initiative, the organisations engaged with their respective communities to help access their immediate needs through participatory processes. Praxis facilitated a community-based evaluation of the relief support provided by partners through a workshop.

BUILDING ORGANISATIONAL CAPACITY

Praxis has contributed to strengthening organisations by holding capacity-building workshops. These include the flagship event TheWorkshop - an international residential workshop that brings together practitioners from around the world; Sandhan -a capacity-building for grassroots month-long format of organisations; and customised workshops for organisations on specific themes. These include participatory action research, the use of PRA with persons with disabilities, digital innovation tools in the use of participatory tools, ethics and research, and more. Praxis also facilitated organisation development and strategy review processes for several organisations over the years. In addition, Praxis conceptualised 'Insight' - a spontaneous learning facilitates policy makers, implementers, process that advocates to live with communities, dialogue with them, and enrich their knowledge and understanding of the people they make policies for.

5	People powered digital narratives	Praxis coordinated the People Power Digital Narrative Project of Children's Investment Fund Foundation with Quilt.ai, PLUC.tv, towards mobilising communities and building digital narratives to enable "ordinary" voices or self-representation to highlight issues of children in mainstream media and reach relevant influencers/ stakeholders.
6	The Workshop 2021	Praxis facilitated its 23rd Workshop online on the theme of "Building Community Resilience during the Pandemic." The workshop saw the virtual participation of 33 participants along with 6 international participants. The Modules Run during this workshop were: a. Participatory Methods and Approaches b. Participatory Monitoring and Evaluation



2	Amplifying Community Voices in Sundarbans	Praxis led a consortium of seven organisations using the participatory grant-making approach to development in Patharpratima block of South 24 Parganas of Bengal. The project aimed to enable identified groups of vulnerable people in the Sundarbans to come together, diagnose their vulnerabilities, articulate aspirations and avenues of change, and produce a plan for acting upon a specific vulnerability.

1	Community Development - School Enrolment & Vaccination	Praxis provided technical training to community-based fellows and volunteers as part of the healthcare development programme in Jaipur. This included the creation of a module on child rights.





Anindo Banerjee Memorial Lecture Series


